## CURRENT RESEARCH

## Assessment of Malingering in Litigating Patients

Developing methodology to reliably distinguish individuals faking or exaggerating disability due to injury or pain from those experiencing genuine disability, using objective psychological measures as well as archival data from functional capacity evaluations conducted by physical therapists. Also investigating psychological variables predictive of outcome following injury involving pain.

#### Interpretation bias in relationship anxiety

Using cognitive methodologies previously applied to anxiety disorders, investigating interpretation biases in individuals reporting high levels of anxiety concerning interpersonal relationships.

#### Judgment bias in relationship anxiety.

Using cognitive methodologies previously applied to anxiety disorders, investigating judgment biases in individuals reporting high levels of anxiety concerning interpersonal relationships.

#### Nightmare treatment outcome study in combat veterans with PTSD

In collaboration with the New Orleans VA Hospital Inpatient PTSD program, using a cognitive-behavioral treatment for recurrent nightmares.

#### Nightmare treatment outcome study

Cognitive-behavioral treatment of non-recurring nightmares in an undergraduate population at the University of Georgia, with 1-month and 3-month followup. Manuscript under review.
