Research Focus

Throughout my research career I have studied psychological and neuropsychological assessment and psychometrics. Since 2000, my research has specifically focused on methods to improve the accuracy of psychological and cognitive assessment and to better identify factors associated with poor outcome in a variety of conditions. Failure to recover after injury or illness is a significant health problem that is closely tied to a variety of psychosocial factors including personality and coping styles, psychopathology, stress, work satisfaction, and financial factors. Ongoing and future research aims to improve our understanding of the influence of the full range of social factors, personality, and psychopathology on outcome following illness or injury.
